

Articles of Incorporation

Non-Profit/Non-Stock Corporation

The undersigned, Curtis M. Brown, whose address is 2018 Brigadier Blvd., Odenton, MD 21113, being at least eighteen years of age, does hereby form a corporation under the laws of the State of Maryland.

FIRST: The name of the corporation is:

United Council of Christian Fraternities and Sororities, Incorporated

SECOND: The place in Maryland where its principal office is to be located is 6419 York Road, Baltimore, MD 21212. This Corporation may have other offices within or outside of the State of Maryland at such place or places as the Board may from time to time appoint or the business of the Corporation may require.

THIRD: The purposes for which the corporation is formed are as follows:

- A) Provide a vehicle for cooperative ministry between the member organizations
- B) Promote fellowship among the Christian fraternities and sororities on college/university campuses and throughout the world.
- C) Encourage and facilitate the training and development of fraternity and sorority ministry leaders

The manners and ethics of this corporation are governed by the principles found in the Holy Scriptures (Bible). This body shall have no legal or governmental authority over its member organizations other than its right to adjudicate alleged violations of the code of ethics and conduct for the purpose of determining revocation of membership from this corporation.

FOURTH: The name of the resident agent of the corporation in Maryland is Curtis M. Brown whose address is 2018 Brigadier Blvd., Odenton, MD 21113

FIFTH: The Corporation has no authority to issue capital stock.

SIXTH: The number of directors of the corporation shall be **Three** which number may be increased or decreased pursuant to the bylaws of the corporation. The name(s) of the director(s) who shall act until the first meeting or until their successors are duly chosen and qualified is/are:

SEVENTH: Under the provision of Section 501(c)(3)of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, this corporation is organized exclusively for charitable, religious or education purposes. It does not seek to attempt to influence legislation as a substantial part of its activities, including participating in any campaign activity for or against political candidates. No member or officer of this organization, or any private individual, shall receive at any time any of the net earning or pecuniary profit from the operations of this organization, provided that this shall not prevent payment to any person as such reasonable compensation for service rendered to or for the organization in affecting any of the purposes for which this organization is formed; and no such person shall be entitled to share in the distributions of the organization's assets upon the dissolution of the organization.
